Marina Site: Made arrangements for the Anglers Marina Ship's Store to move out of premises during construction. Completed heating and air conditioning and electrical improvements along with carpentry improvements. Rehabilitated restroom/laundry facilities. Replaced interior flooring. Initiated roof replacement and painting of exterior. Completed replacement of fuel tanks and initiated replacement of dispensers. Removed surplus helium tank from Bay Café site. Secured exposed electrical wires on exterior lighting. Consulted with SCE&G regarding on ground transformer. Currently in process of separating water service lines among Jeffords, Maintain and Tidal Wave Runners. Contracted with General Engineering Labs for site assessment for assurance that construction related to the fuel systems does not exacerbate the site contamination problem (prior owner). Applied to SC DHEC OCRM for reimbursement of expenses associated with update of the vessel sewer pump out.

Generator: Submitted grant application to the State Hazard Mitigation office for possible funding for improvements to generator service at all City facilities.

Accommodations Tax: Worked with Treasurer Suggs and Barbara Brown of the Department of Revenue to arrange a training session for February 21st, 2001.

Cost to Serve: Working with City Treasurer Suggs and Charleston County, began efforts to determine revenues vs. expenses on the two shopping center properties.

Marina Management: Working with Chairman of Ways and Means, Treasurer Suggs and Brian Berrigan began evaluation of existing Marina Management Agreement to determine new elements needing consideration for future agreement.

Dispatching Agreement: To be in conformance with CALEA requirements for accreditation, initiated efforts to implement a written agreement between Isle of Palms and Sullivan's Island for dispatching services.

Noise: Began working with residents in the Wild Dunes area and management of Destination Wild Dunes in an effort to mitigate negative impacts on the neighborhood associated with events.

Breach Inlet Bridge Construction: Made arrangements to have twenty-four (24) hour contact person for problems associated with construction.

OSHA: Made improvements to City Hall and submitted appropriate documentation as recommended by the OSHA courtesy visit.

Automatic Aid and Mutual Aid: Met with neighboring Fire Chiefs to determine feasibility of entering into an automatic aid agreement with Mount Pleasant. Continue to evaluate recent improvements in emergency response.

Animal Control: Revised animal control ordinance to experiment with allowing dogs to run on the beach, during specific hours with the owner present with a leash in hand.

Breach Inlet Boat landing: Fire Department and Public Works have made two visits to this site to remove rock hazards. The staff will continue to work on more permanent methods to prevent the problem for re-occurring.

41st Avenue Reconfiguration: Met with County staff and residents whose properties might be affected by the proposed change in this area.

Accreditation: Have worked with Chief and his staff on the revision of seventeen (17) policies to be prepared for this process.
