The following is a synopsis of some of the activities of the Isle of Palms Police Department during the month of April 2009.

Patrol

April 1, 2009 Investigators arranged for two male subjects that had outstanding Arrest Warrants to turn themselves in this date. Both arrived at headquarters and were each served with Breach of Trust with Fraudulent Intent (less than \$1,000) warrants and were processed and transported to the Charleston County Detention Center. The warrants are the result of an investigation into the illegal use of a home on Cameron Boulevard that they were entrusted with to complete repairs.

April 3, 2009 Officers responded to a residence on Palm Boulevard, where a passerby reported hearing a woman yelling for help. The officers spoke to a witness who stated that there was an intoxicated and irate male subject inside punching holes in walls and assaulting people. The witness identified the subject by name and stated that he had just exited the rear door. The subject was immediately located and detained. It was determined that the subject had assaulted his girlfriend, she was uncooperative and did not want him charged, but two houseguests were also assaulted and provided written statements. The officers witnessed a large fist size hole in one wall and three holes in three different doors. The subject was arrested and charged with Simple Assault 2 counts, and Malicious Damage to Real Property, and transported to the Detention Center.

April 5, 2009 A female subject who had spent the weekend on the Isle of Palms while attending the Bridge Run returned to her home in Charlotte, North Carolina and reported to the Charlotte-Mecklenburg Police Department that she had been sexually assaulted while at the Isle of Palms. She reported that she knew the first name of the suspect, but no other information. Arrangements were made for a written statement to be taken, which

was immediately faxed to the Isle of Palms. An Isle of Palms officer spoke to the victim and gained as much information as possible. An Investigator was assigned to this case, and was able to positively identify the male subject. The alleged victim then decided not to pursue charging the subject.

April 7, 2009 A local liquor store reported that a male juvenile had attempted to purchase liquor with an altered identification card. An officer observed the subject hiding behind a nearby business and when the officer approached the subject ran into a wooded area. The subject ran through yards and made his way to the Recreation Center then into, and through yards again. The subject's father met with an officer at the liquor store, and was less than cooperative, but he eventually made telephone contact with the suspect and his friend who had been in a vehicle to pick the suspect up after the purchase had been made. Both subjects were charged with Purchasing Alcohol with False ID. The subject that entered the store and ran was also charged with Hindering and Resisting Arrest. It was determined that the subject's were visiting Wild Dunes with their families.

April 8, 2009 Just before 11:30 P.M., officers responded to a Cameron Boulevard residence, where a loud party had been reported. The officers immediately observed beer bottles and drink cups strewn around the outside of the residence and a large number of male and female subjects at the residence, who appeared to be teenagers. Located in the residence were twenty-three subjects, two over the age of twenty-one, two juveniles, and nineteen between seventeen and twenty years old. It was discovered that a male subject had jumped from a second story porch to avoid detection by the police and as a result sustained a broken jaw and hand. Two adult subjects were charged with Transfer of Beer/Liquor to a Minor, and Violation of the Noise Ordinance. The two juveniles were charged with Underage Possession of Beer and Liquor to be tried in Family Court. The remaining subjects were charged with varying charges of Possession of False ID to Underage Possession of Beer, and Underage Possession of Liquor. All of the beer and liquor found in the residence was confiscated, photographed and destroyed. A representative of the rental company responded and advised that all subjects present were to be out of the residence by 10 A.M. the following morning and damaged items would be charged to the credit card of the person who is listed on the rental agreement.

April 9, 2009 Officers responded to a Hartnett Boulevard residence regarding a reported disturbance between brother and sister at that location. While investigating it was discovered that the male subject had an outstanding Arrest Warrant through the Rhea County Tennessee Sheriff's Department. A teletype from that agency indicated that they would not extradite. The disturbance was resolved for the evening with the brother indicating that he would move out of the residence.

April 10, 2009 Officers were alerted by several 911 calls that an aircraft was flying very low, southbound over the beach. The Department of Natural Resources aircraft was having fuel problems and was forced to land on the beach near 32nd Avenue. The area around the aircraft was cleared for safety reasons and approximately three hours later the problem was repaired. Police, fire and DNR personnel cleared a one- mile stretch of beach and a successful takeoff was accomplished without further incident.

April 10, 2009 Two male juvenile subjects entered a local liquor store and shoplifted a mini keg of beer then ran to a wooded area near the Connector. One subject was apprehended and charged with Shoplifting, Underage Possession of Tobacco Products and Underage Possession of Beer. Since he was a juvenile he was released to the custody of a parent. His case will be heard in Family Court.

April 11, 2009 At approximately 1 A.M., an officer on patrol observed a vehicle quickly turn onto the Connector, almost striking the cement median. The officer followed the vehicle and again observed it operating erratically, then stopped the vehicle to investigate. While speaking to the driver the officer immediately detected a strong odor of alcohol, and noted that the driver had a hard time providing the necessary documents. The driver submitted to several Field Sobriety Tests, which he failed, then later refused to provide a sample for the Datamaster Test. He was charged with DUI, and transported to the Detention Center.

April 11, 2009 At the request of the Mount Pleasant Police Department an Isle of Palms officer met at a residence on Palm Boulevard in reference to an accident in Mount Pleasant that was being investigated. The Mount Pleasant officer took the suspect driver into custody from his residence.

April 11, 2009 While conducting a traffic stop on Palm Boulevard, an intoxicated male subject appeared, then began to interfere with the stop, demanding to know what was happening, and yelling profanities. The subject was instructed to leave the area several times and was taken into custody when he refused to do so and charged with Hindering.

April 12, 2009 At approximately 1:30 A.M., officers responded to the beach behind The Seaside Inn where loud noise had been reported. Officers encountered one male and three female subjects, and made the determination that a couple in the group was in the process of a heated argument, which continued in the officer's presence. While the officers attempted to calm the male subject down, it was determined that all four were in possession of alcohol. All four subjects were charged with No Alcohol on the Beach, two subjects with Disorderly Conduct and one with 3 counts of NRVC, for unpaid traffic tickets.

April 12, 2009 A male subject reported that after a verbal altercation in a front beach establishment, a male subject jumped him in a nearby parking lot. He stated that the subject's girlfriend then deliberately backed her car into the subject knocking him down each time. The case has been assigned to an Investigator for follow-up.

April 12, 2009 Residents of Waterway Boulevard reported that their golf cart with an attached bicycle had been stolen from their driveway. The couple drove around looking for their vehicle and observed it being operated by two male subjects, which they immediately reported to the police department. Prior to police arrival, the couple stopped the vehicle and confronted both subjects who claimed ownership. The responding officer took the subjects into custody, and charged them both with Grand Larceny of a Motor

Vehicle. Both were identified as juveniles visiting from North Carolina. Their cases will be heard in Family Court.

April 16, 2009 An officer was flagged down on Palm Boulevard for an incident that had just occurred at a jobsite on Ocean Boulevard, where the victim reported that he had been assaulted by several angry employees over not receiving their pay in a timely manner. Persons at the jobsite were not helpful in assisting. The case has been assigned to an Investigator to pursue charges.

April 16, 2009 At approximately 10 A.M., an officer observed a vehicle operating erratically on 41st Avenue. The driver was determined to be a disoriented elderly male from Mount Pleasant who has been escorted home on other occasions. The subject was driven to his residence and arrangements were made for his vehicle to be returned. Due to this re-occurrence a request for driver reexamination to the highway department was submitted.

April 16, 2009 Just before midnight, officers responded to the 3600 block of Palm Boulevard on the beach, where a citizen had reported fireworks being shot off. Officers located three male subjects actively shooting fireworks on the beach. All three were cited for No Fireworks on the Beach, and advised to leave the area.

April 17, 2009 Just before 2 A.M., an officer on patrol stopped to investigate a vehicle stopped on Palm Boulevard with headlights on, drivers door open and running. The officer found a male subject passed out behind the wheel of the vehicle, and when awakened was found to be in no condition to make arrangements to be picked up. He was taken into custody and charged with Public Intoxication.

April 17, 2009 At approximately 2:30 A.M., officers responded to a residence on 42nd Avenue and were met by a complainant who stated that a group on the porch of a nearby residence had been playing loud music and using loud profanities heard throughout the block. Officers eventually made contact with someone in the residence and the person that rented the residence was cited for Violation of the Noise Ordinance.

April 18, 2009 Just after midnight, an officer on patrol observed nine vehicles parked at a rental residence on Palm Boulevard. As officers approached the residence, several subjects on the porch dropped their drinks and ran into the residence. The officers then observed a beer keg on tap on the porch, and attempted to make contact with the person responsible for the rental. The officers noted that almost everyone present appeared to be under the age of 21, and noted a substantial amount of alcoholic beverages present. A nineteen year- old male subject stated that his parents rented the home for him. Present in the home was a 50 year- old female subject, who along with two 21 year olds were charged with Transfer of Beer to Minors. The remaining fifteen between the ages of 17 and 20 were all charged with Underage Possession of Beer. All alcohol present was photographed and destroyed.

April 18, 2009 Just before 4:30 A.M., officers responded to a citizen complaint of loud noise on the beach behind Grand Pavilion in Wild Dunes. Responding officers overheard loud yelling then observed several subjects sitting on the beach around a fire, and several sitting in the dunes. A large quantity of beer cans and liquor bottles were strewn about the area. Some persons present ran from the area, but eight were detained, and were instructed to extinguish the fire and clean the area. Five subjects were charged with Underage Possession of Beer, and Violation of the Noise Ordinance. Two additional subjects were charged with No Alcohol on Beach, and Violation of the Noise Ordinance. An unruly male subject was transported to the Detention Center charged with No Alcohol on Beach, Violation of the Noise Ordinance, and Littering. A knapsack containing a quantity of marijuana and drug paraphernalia was seized with charges pending against the owner.

April 18, 2009 A woman visiting the island reported that while she walked her dog on the beach her 2009 Toyota Camry was stolen from a metered parking spot in front of Sea Cabins. She stated that a window was ajar and an ignition key was on the console.

April 19, 2009 An officer on patrol observed a disabled vehicle on Charleston Boulevard at Palm Boulevard, and as the officer approached to provide assistance, the owner closed the hood and drove over to the nearby boat ramp. The officer then observed another male subject in a jeep waiting to back down the boat ramp to load a boat onto a trailer. The officer spoke to the driver of the jeep, who had very slurred speech who stated that he was waiting for the officer to leave first. The officer had the driver of the jeep exit the vehicle and determined that he was impaired. The driver admitted that he had consumed 6-7 beers. The male subject that had been in the disabled vehicle then approached when it was determined that he too was under the influence of alcohol. Both subject were taken into custody and charged with Public Intoxication. It was later determined that the jeep had been involved in a hit and run accident in Mount Pleasant prior to the initial contact at the boat landing. Fresh damage to the jeep matched what was described, Mount Pleasant Police responded to investigate.

April 20, 2009 After stopping a vehicle for an equipment violation, a computer check of the driver indicated that he was wanted by the Dorchester County Sheriff's Office for two counts of Uttering a Fraudulent Check. He was taken into custody and later transferred to the custody of a Dorchester County Deputy without further incident.

April 20, 2009 A male subject who absconded to California after committing several crimes on the Isle of Palms was returned to Charleston by a Bounty Hunter for a pending General Sessions Court Bench Warrant. Upon his return to the Charleston County Detention Center, one of our Investigators served Arrest warrants on the subject for a September 2008 incident of Break-in to a Motor Vehicle. He was also charged with Burglary 1st degree, and Grand Larceny of a Motor Vehicle for two separate January 2009 incidents. He was arrested on unrelated charges in Los Angeles, while driving the vehicle stolen from the Isle of Palms, but at the time the Solicitor's Office refused to extradite him until a local Bondsman became involved.

April 23, 2009 A vehicle stolen from the front beach area this past Saturday was recovered in Ladson by the Charleston County Sheriff's Office after a traffic stop. Two of the three occupants ran from the scene. An Investigator had been assigned to the case and will now work with the Sheriff's Office in gathering evidence from the vehicle.

April 25, 2009 At the request of a Sullivan's Island police officer, the Isle of Palms Police Department provided a Datamaster Operator to test a subject that they had in custody, suspected of DUI. The test was administered and the subject was charged with DUI.

April 25, 2009 At approximately 11:30 P.M., officers responded to a noise complaint at a Palm Boulevard residence. The officers encountered loud music, talking and laughter coming from the residence, and as they approached, some subjects ran from the yard. The officers located the person responsible for the rental and confirmed that he was the host of the party. He was charged with Minor in Possession of Beer, Violation of the Noise Ordinance, and Exceeding Maximum Occupancy. Ten other subjects were also charged with Minor in Possession of Beer. The rental company responded and took custody of the keys and evicted all subjects present. The alcohol present was photographed then destroyed. All of the subjects evicted were given the opportunity to locate a sober driver to take them safely back to their homes for the evening.

April 25, 2009 Officers responded to a complaint of loud noise from a residence on Forest Trail. Responding officers observed many vehicles parked on the side of the side of the road, and in neighbor's front yards and went to the residence in question, and quickly located the host of the party. It was determined that of the fifty-eight persons present, thirty-six were underage. The host was charged with Transfer of Beer to Minors, Violation of the Noise Ordinance, and Exceeding Maximum Occupancy. Thirty-Six subjects were charged with Underage Possession of Beer. The rental agent responded, where all persons present were immediately evicted. The alcohol present was photographed then destroyed. All subjects charged were given the opportunity to contact a sober driver to take them safely back to their homes for the evening.

April 26, 2009 Three subjects walking on the beach at approximately 2 A.M., reported that they were assaulted by a group of male and female subjects on the beach after being unable to provide a cigarette to someone in the group. After two of the subjects were assaulted, they ran off of the beach and made contact with a police officer to report the incident.

April 26, 2009 An officer responded to Palmetto Drive and Sun Dial Circle to handle an accident that had been reported. Upon the officer's arrival, he determined that the vehicle at fault had left the scene, and a good physical description of the driver and the vehicle was provided. A short time later the officer located the vehicle and the driver behind an apartment complex on Hartnett Boulevard. The driver was identified and taken into custody charged with Leaving Scene w/Property Damage, No Driver's License, and Hindering.

April 26, 2009 Officers responded to a front beach establishment that reported an assault to an employee at their business. Management did not wish to pursue charges, but requested that the subjects be placed on Trespass Notice. The subject's were advised and allowed to leave without further incident.

April 27, 2009 An officer stopped a vehicle for an equipment violation and while speaking with the driver detected a strong odor of alcohol emitting from the vehicle. The driver was very nervous and unable to provide the necessary paperwork requested. When the driver exited the vehicle to perform Field Sobriety Tests, he was found to be in possession of a quantity of marijuana. The driver was taken into custody and charged with DUI, Simple Possession of Marijuana, and Unsafe Equipment.

April 29, 2009 Investigators arrested a couple responsible for the theft of a vehicle from the front beach, which was recovered in Charleston County on April 23rd. Both subjects were charged with Grand Larceny of a Motor Vehicle, Financial Transaction Card Fraud 9 counts each, and Grand Larceny. The Charleston County Sheriff's Office also had outstanding Arrest Warrants due to the traffic stop that resulted in the stolen vehicle recovery.

April 30, 2009 Officers responded to the area of the County Park where several citizens reported a fight in progress on the beach. The responding officers immediately located three subjects involved and a short time later located the other two. They stated that an argument started between males over comments made to a girlfriend. The verbal argument escalated to a fight, which resulted in one subject sustaining a possible dislocated shoulder. Since the victim refused to prosecute, no charges were made, however all involved were placed on Trespass Notice to the park for six months.

Personnel/Community Relations

April 1, 2009 Sgt. Usry received a Letter of Appreciation from South Carolina law Enforcement Accreditation, Inc, for her assistance in conducting an onsite assessment at the Newberry Police Department.

April 4, 2009 PFC Baldrick, a Certified Child Safety Seat Installer met with an expectant mother to supervise installation of a child safety seat in her vehicle.

April 14, 2009 PFC Chavez received a Letter of Appreciation from a recent visitor to Wild Dunes who had her laptop computer stolen, but recovered through PFC Chavez diligent work in locating the property.

April 19, 2009 Officers provided traffic control for the Annual East Cooper Triathlon.

April 30, 2009 For the month of April, officers discovered three businesses and two homes with open or unsecured doors. A total of twelve Victim of Crime Forms were issued to business or property owners for various violations noted, or to advise them that an officer checked their location during the night while on patrol.

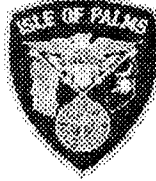
