

## **SPECIAL MEETING OF CITY COUNCIL**

Tuesday, January 5, 2016

A special Meeting of City Council was called to order immediately following the Inauguration of new Councilmembers at 6:15 p.m., Tuesday, January 5, 2016 in Council Chambers of City Hall, 1207 Palm Boulevard, Isle of Palms, South Carolina. Attending the meeting were Councilmembers Bergwerf, Bettelli, Carroll, Ferencz, Harrington, Kinghorn and Ward, Mayor Cronin, City Administrator Tucker, Attorney Halversen, Assistant City Administrator Fragoso and Clerk Copeland; a quorum was present to conduct business. The absence of Councilmember Rice was excused.

Mayor Cronin called the meeting to order and acknowledged that the press and public had been duly notified of the meeting in accordance with the Freedom of Information Act.

**MOTION:** Mayor Cronin moved to approve the slate of candidates for the 2016 appointments to Boards and Commissions as recommended by the Personnel Committee (the list is attached to the historical record of the meeting); Councilmember Kinghorn seconded and the motion **PASSED UNANIMOUSLY**.

**MOTION:** Mayor Cronin moved to approve his appointments to standing committees of Council for 2016 (the list is attached to the historical record of the meeting); Councilmember Harrington seconded and the motion **PASSED** on a vote of 7 to 1 with Councilmember Carroll casting the dissenting vote.

**MOTION:** Mayor Cronin moved to reappoint Marty Bettelli to the CARTA Board; Councilmember Carroll seconded and the motion **PASSED UNANIMOUSLY**.

**MOTION:** Mayor Cronin moved to appoint himself to be the City's representative for the Charleston Visitor's Bureau and the Council of Governments; Councilmember Bettelli seconded and the motion **PASSED UNANIMOUSLY**.

**MOTION:** Mayor Cronin moved to appoint Michael Molony as Municipal Judge and John Duffy as Assistant Municipal Judge; Councilmember Carroll seconded and the motion **PASSED UNANIMOUSLY**.

**MOTION:** Mayor Cronin moved to appoint Stirling Halversen the City Attorney and Julia Copeland the Assistant City Attorney; Councilmember Bergwerf seconded and the motion **PASSED UNANIMOUSLY**.

**MOTION:** Mayor Cronin moved to re-appoint Councilmember Bettelli to the CARTA Board; Councilmember Bergwerf seconded and the motion **PASSED UNANIMOUSLY**,

The Mayor made brief remarks about what the City accomplished in 2015 and directed attention to the 2016 Accomplishments booklets that were available at the back of the room.

The meeting was adjourned at 6:25 p.m. and everyone was invited to stay for the social hour to follow.
