Call Summary

August 2010

- 8/1/10 Units responded to a report of a lost child on the beach. Upon arrival it was determined the child did not speak English. Fire Department personnel were able to communicate with her and obtain a description of her parents. A search for the parents was begun, and within minutes they were located and reunited with their child.
- 8/2/10 Units responded to the intersection of Palm Boulevard and 5th Avenue for a possible brush fire. Upon arrival crews found a palm tree and the surrounding ground cover on fire. A 1 ¾" hand line was pulled and the fire extinguished.
- 8/4/10 Units responded to a residence on Sandcrab Court to investigate a report of a missing elderly resident. Upon arrival at the home, personnel gathered information about the missing person and began a search. After a short search the resident was found walking along Back Bay Drive and returned to their home.
- 8/5/10 Units received a call of smoke in the house at a residence on Ocean Boulevard. Dispatch advised that all occupants were exiting the building at the time of the call. Upon arrival personnel entered the home and found a light haze of smoke. Following a brief investigation it was determined the source of the smoke was an air handler. The power to the unit was secured and the resident advised to have a maintenance person look at the air handler before using it again.
- 8/6/10 Units responded to a report of a child locked inside a vehicle. Upon arrival the crew met with the mother and found the child inside a running vehicle. The child did not appear to be in any distress and a locksmith was called. Once access was gained the crew evaluated the child and turned him over to the mother.
- 8/11/10 Mount Pleasant Fire Department requested mutual aid for a working structure fire. While enroute to Station 4 to provide coverage, Engine 1 was redirected to the scene of the fire. Upon arrival the crew assisted with overhaul on the first and second floors of the residence. Once the assignment was completed Engine 1 was released from the scene and asked to relocate to Station 5 for coverage. After about an hour, Engine 1 was released from standby and returned to the island.
- 8/11/10 Units responded to a report of a swimmer in distress in the ocean behind Port-O-Call. Upon arrival personnel met with the swimmers father who directed them to the area where his son was last scene. Crews were able to obtain visual contact with the swimmer who was on a sandbar. Boat 6 was launched and proceeded to the sandbar. Once there, personnel retrieved the swimmer and returned him to shore.

Call Summary

August 2010

- 8/11/10 Units responded to a report of a kite boarder in distress in the Intracoastal Waterway behind the Carroll Realty building on Palm Boulevard. Upon arrival crews obtained a visual on the kite boarder and prepared to launch a watercraft. Before the craft could be put in the water a civilian watercraft in the area came to the victim and assisted them back to the dock. Kite boarder was evaluated for injuries and released.
- 8/13/10 Units responded to a report of a "man down" on the beach. Dispatch advised that CPR was in progress at the time of the call. Upon arrival crews found several bystanders performing CPR and assumed care of the patient. As care continued the patient was packaged for transport and loaded in to the bed of Rescue 3. Once off the beach, personnel transferred care of the patient to Charleston County EMS. The patient was transported to East Cooper Hospital.
- 8/31/10 Units responded to a report of smoke coming from a building at the corner of Ocean Boulevard and 14th Avenue. Upon arrival residents were self-evacuating from the building, but no fire or smoke conditions were visible from the exterior. An occupant from the third floor had made the call and told crews he believed the smoke came from the unit directly below his. Personnel laddered the balcony of the second floor unit and were able to gain access to the unit through the sliding glass door. A thorough investigation of that unit and the adjoining units revealed no signs of smoke or fire. All units returned to service.
