Call Summary

December 2011

- 12/11/11 Personnel responded to a report of smoke inside a residence on Morgan Place Drive. Upon arrival, personnel entered the building and were directed to the third floor fireplace. The fire had been extinguished, but when the crew removed the glass front of the fireplace they could hear some crackling and found the remains of a bird's nest in the chimney. The burning nest was removed and no extension of the fire was found. The resident was advised to have the chimney cleaned before using again and all units returned to service.
- 12/13/11 A resident came to Fire Station No. 2 because he had seen water leaking from his neighbor's home and he knew they were out of town. Personnel responded to a residence on 42nd Avenue and upon arrival found water running outside the house. The Isle of Palms Water Company was notified. It was determined the water was coming from a broken spigot and the water supply to the residence was shut off. The Isle of Palms Water Company was going to make contact with the resident. All fire units returned to service.
- 12/15/11 Personnel responded to a report of a fire in the kitchen at a residence on Hartnett Boulevard. Upon arrival, personnel found the fire had been extinguished by the resident, but there was damage to the vent hood and the cabinets above the stove. The crew checked for fire extension and found none. All units returned to service.
