**Call Summary**  
*April 2015*

- 4/3/15 Personnel responded to a report of a grass fire that was threatening a structure on Beachwood East. Upon arrival the crew found a resident extinguishing the grass fire. Crews quickly assisted with extinguishment and checked for extension into the residence. None was found, overhaul was completed, and all units returned to service.
- 4/4/15 Personnel responded to a report of a boater in distress in Caper's Inlet. Boat 1020 was launched and upon arrival in the area found two kayakers on the beach. Boat 1020 was unable to approach due to the shallow water near the beach, but could communicate with both parties who advised one of the kayakers had a problem. Both kayakers said they could make it to Boat 1020. Once aboard Boat 1020 all parties were returned to the Isle of Palms Marina. No further assistance was needed and all units returned to service.
- 4/15/15 Personnel responded to a report of a deer in distress in the surf behind Grand Pavilion. Upon arrival crews found a deer in the ocean. A jet ski was launched to try and bring the deer back to the beach. After a lengthy effort the deer was brought to shore, but it was pulseless and not breathing. Efforts were made to resuscitate the animal, but they were unsuccessful. The deceased animal was placed in the back of the Animal Control vehicle and all other units returned to service.
- 4/30/15 Personnel responded to a report of a gas odor in the area of J-Dock behind 1 Morgan Creek Drive. Upon arrival crews searched for the source of the odor. Personnel met with the boat owner who made the original call and after a thorough check of his boat they found a small amount of gas had come out of the overfill vent. It was determined no gas had leaked into the waterway. No further action was taken and all units returned to service.

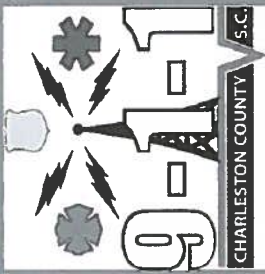
